**ORDINANCE NO. 2024-01**

**AN ORDINANCE TO AMEND CHAPTER 93 OF TITLE IX OF THE VILLAGE OF  
BIRCH RUN CODE**

**[Health and Sanitation]**

THE VILLAGE OF BIRCH RUN ORDAINS:

**Section 1.** Section 93.02 of Chapter 93 of Title IX of the Village of Birch Run Code is hereby amended in part to read as follows:

§ 93.02 DEFINITIONS.

*JUNK MOTOR VEHICLES OR TRAILER.* Any vehicle or trailer which is not licensed for use upon the highways of the State of Michigan for a period in excess of 30 days, and shall also include, whether licensed or not, any motor vehicle or trailer which is inoperative for any reason for a period in excess of 30 days; provided that there is excepted from this definition, operative vehicles or trailers which are kept as the stock in trade of a regularly licensed and established new or used automobile dealer or trailer dealer, provided further the vehicles or trailers excepted as are upon the premises of a motor vehicle or trailer repair garage.

**Section 2.** Severability. If any section, subsection, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent portion of this

Ordinance, and such holding shall not affect the validity of the remaining portions of this Ordinance.

**Section 3.** Effective Date. This ordinance shall be published not less than ten (10) days following adoption in a local newspaper of general circulation in the Village. This ordinance shall become effective upon its publication.
